ARTICLES OF INCORPORATION

OF

T. F. S., INCORPORATED

THE UNDERSIGNED, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is T. F. S., Incorporated.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are:

- 1. The development of products and processes and the patenting thereof.
- 2. The licensing, manufacturing and marketing of all patented products and processes owned by the corporation.
- 3. The transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.
