ARTICLES OF INCORPORATION

'80 ATTICLE AM 9 15

This corporation shall be known as the Cataldo Mennonite Church Inc., hereinafter referred to as "the church" or "the corporation".

STATE Article II

The church shall be a religious society and a nonprofit corporation. All incomes shall be dispensed in accordance with the following purposes or paid as compensation in reasonable amount for services rendered. No dividend shall be paid and no part of the income shall be distributed to directors, members or officers unless paid as above stated compensation for services.

Article III

The church shall be of perpetual duration. There shall be no capital stock. In the case of any future dissolution, the proceeds shall go to the mother church, Porter congregation, Rt. 3, Estacada, Oregon, and shall be dispersed at their discretion.

Article IV

The purposes of the church shall be as follows:

- (a) To perpetuate the practice of the doctrines set forth in the Holy Scriptures in their purity.
- (b) To strengthen all believers and to instruct our children, youth, and homes in the ways of the Lord.
- (c) To advance the faith of Jesus Christ by helping the unsaved reach a personal knowledge of the Living Christ.
- (d) To provide a place of worship for the local congregation and community.

Article V

The board of directors shall be the local minister(s) and bishop in charge of the spiritual leadership of the congregation. The corporation shall have no members but shall vest the management of its affairs in the local body of brethren. The board of directors may appoint any committee(s) deemed expedient to manage any affair(s) of the corporation.

Article V (cont.)

The first board of directors shall be the two (2) identified below:

Dennis Carpenter (local minister) Rt. 1, Box 225 Cataldo, Idaho 83810

Ermest J. Pontrager (Bishop in charge) Rt. 3, Box 1032 Estacada, Oregon 97023

These directors, and any who may be added later, shall hold office until their resignation or until such time as the members of the church shall by a 2/3 majority vote disqualify and/or replace them individually or collectively. Directors shall be appointed in accordance with regular church ordination procedure.

This article is in accordance with I.C., §§ 30-314, 30-315, 30-317, 30-318

Article VI

The church secretary shall keep correct and complete books and records of account and shall keep minutes of the proceedings of any meeting of the members of the congregation officially called to discuss affairs of the corporation. Any meeting shall be considered officially called if announced publicly at any regularly scheduled worship service.

Article VII

The church is located on CCC Rd. Cataldo, Idaho. The address of the registered office shall be Rt. 1, Box 5-G, Cataldo, Idaho 83810. Marvin Strubhar shall be the registered agent of the corporation at that address.

Article VIII

Amendment of these articles may be made by a majority vote submitted by the members of the congregation, at any regular or special meeting announced at a regularly scheduled worship service.
