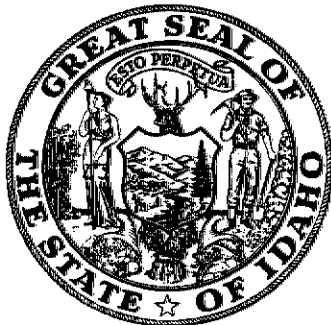

**ARTICLES OF INCORPORATION**  
**(For Profit Corporation)**  
**COMMUNITY SUPPORT CENTER INC.**

The undersigned, acting as incorporators under the Forprofit Corporation Act, adopt the following Articles of Incorporation:

**ARTICLE ONE**

**NAME**

The name of the corporation is "Community Support Center" Inc. The corporation will have the authority to issue 5,000 shares of stock with no par value.

**ARTICLE TWO**

**FOR PROFIT CORPORATION**

The corporation is a forprofit corporation.

**ARTICLE THREE**

**DURATION**

The duration of the corporation shall be perpetual.

**ARTICLE FOUR**

**PURPOSE**

The corporation is organized and operated exclusively for the treatment, support, training and education of people with mental disabilities. To further these purposes, the corporation shall attempt to provide training, resources, and shall help advocate for services to people who because of a mental disability or limitation require such services in order to achieve their goals of rehabilitation and or social independence.

**ARTICLE FIVE**
