The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the Corporation is HANSEN SPORTS, INC.

SECOND: The period of its duration is perpetual.
