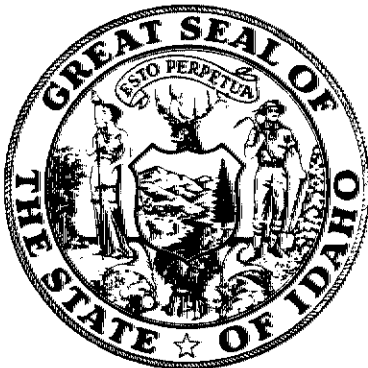
CERTIFICATE OF WITHDRAWAL OF

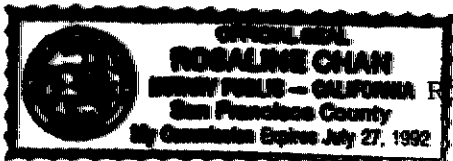
