CERTIFICATE OF PROCEEDINGS FOR EXTENSION OF TERM OF CORPORATE  
EXISTENCE OF REXBURG IRRIGATION COMPANY.

We, the undersigned, John A. Pearson, President, and T. W. Archibald, Secretary, of the Rexburg Irrigation Company, TO HEREBY CERTIFY:

That the annual meeting of the stockholders of said Rexburg Irrigation Company was called according to law, for the purpose of hearing the financial report of the company, electing two members of the Board of Directors, for the transaction of any other business that might properly come before the meeting, including the extension of the term of the corporation existence of the company by making it perpetual. Said meeting was held on the 10th day of January, 1944, at 2 o'clock P. M. in the courtroom of the Court House at Rexburg, Madison County, Idaho, and was conducted according to law; that more than two-thirds of the stockholders being present and voting thereon, it was moved, seconded and unanimously resolved as follows:

"BE IT RESOLVED:

WHEREAS, the term of corporate existence of the Rexburg Irrigation Company has expired and it being the desire of the stockholders of said Rexburg Irrigation Company to extend the corporate existence by making such existence perpetual, and

WHEREAS, more than two-thirds of the issued, outstanding capital stock of said corporation is represented and voting at said annual meeting,

BE IT RESOLVED, that <sup>by</sup>virtue of Chapter 97 of the 1943 Session Laws of the State of Idaho, the term of existence of the Rexburg Irrigation Company is hereby extended to be perpetual.

NOW, THEREFORE, the President and Secretary of the corporation shall be, and they are hereby ~~authorized~~, empowered and directed to prepare and certify to the Secretary of State of the State of Idaho, in triplicate, the proceedings of this meeting relative to the extension of the term of the corporate existence of the Rexburg Irrigation Company, which existence has been made perpetual as heretofore set forth."

that more than two-thirds of the issued, outstanding capital stock of said corporation voted for the passage of said resolution at said meeting held January 10, 1944, as aforesaid.
