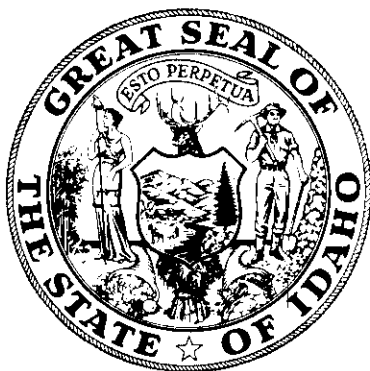

ARTICLES OF AMENDMENT

to the

ARTICLES OF INCORPORATION

of

AMERICAN SOLAR PYRAMID CORPORATION

Pursuant to the provisions of Section 30-1-61 of the Idaho Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: the name of the corporation is American Solar Pyramid Corporation.

SECOND: The following amendments of the Articles of Incorporation were adopted by the shareholders of the corporation on September 3, 1982, in the manner prescribed by the Idaho Business Corporation Act:


That the name of the corporation be changed to "American Solar Pyramids Corporation."

THIRD: The number of shares of the corporation outstanding at the time of such adoption was 1,500; and the number of shares entitled to vote thereon was 1,500. All shares voted in favor of the amendment.
