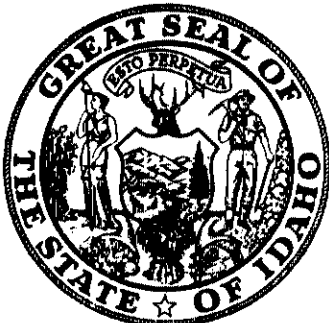
CERTIFICATE OF AMENDMENT OF

Pursuant to the provisions of Section 30-1-61 of the Idaho Business Corporation Act, Evans Brothers Custom Wood Company has adopted the following Articles of Amendment to its Articles of Incorporation:

I

The name of the corporation is Evans Brothers Custom Wood Company.

II

The following amendment of the Articles of Incorporation was adopted by the shareholders and directors of the corporation on November 9, 1993, in the manner prescribed by the Idaho Business Corporation Act:

RESOLVED, that Article I. of the Articles of Incorporation of the corporation be amended to read as follows:

I.

The name of the corporation shall be Evans Brothers Custom Wood Products, Inc.

III

The number of shares of the corporation outstanding at the time of such adoption was 1,000, and the number of shares entitled to vote thereon was 1,000.

IV

The number of shares voted for such amendment was 1,000, and the number of shares voted against such amendment was 0.
