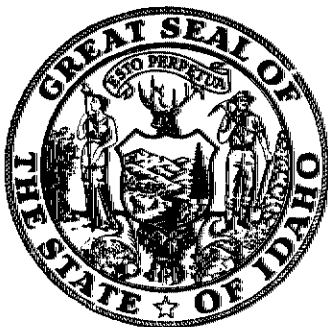

**ARTICLES OF INCORPORATION  
OF  
BONNER VENTURES, INC.**

I, the undersigned, a natural person over the age of eighteen years of age, acting as incorporator of a corporation under the laws of the State of Idaho, adopt the following Articles of Incorporation for such corporation.

**ARTICLE I.**

The name of the Corporation is BONNER VENTURES, INC.

**ARTICLE II.**

The period of its duration is perpetual.

**ARTICLE III.**

The purposes for which the Corporation is organized are to transact any or all lawful business for which corporations may be incorporated under the Idaho Business Corporations Act.
