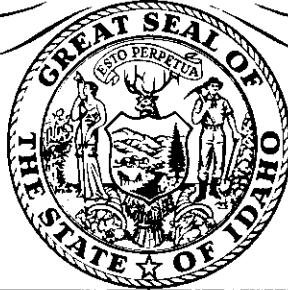

### CERTIFICATE OF INCORPORATION

I, ARNOLD WILLIAMS, Secretary of State of the State of Idaho, and legal custodian of the corporation records of the State of Idaho do hereby certify that the original of the articles of incorporation of

**BOB NICHOLS OIL CO. OF NAMPA, INC.**

was filed in the office of the Secretary of State on the **Twenty-ninth** day of **December** A.D. One Thousand Nine Hundred **Fifty-nine** and duly recorded on Film No. **109** of Record of Domestic Corporations, of the State of Idaho, and that the said articles contain the statement of facts required by Section 30-103, Idaho Code.

I FURTHER CERTIFY, That the persons executing the articles and their associates and successors are hereby constituted a corporation, by the name hereinbefore stated, for **perpetual existence** from the date hereof, with its registered office in this State located at **Nampa,** in the County of **Canyon.**

ARTICLES OF INCORPORATION  
OF  
BOB NICHOLS OIL CO. OF NAMPA, INC.

I.

The name of this corporation is: BOB NICHOLS OIL CO. OF NAMPA, INC.

II.

The purposes for which this corporation is formed are:

(a) To engage in the wholesale and retail business of buying, selling and distributing gasoline, kerosene, lubricating oils, greases, oil products of all kinds, anti-freezes, tires and other supplies for automobiles, tractors and trucks.

(b) To establish and maintain and operate gasoline filling stations; repair tires, lubricate and wash cars; and do everything generally done by those engaged in that line of business.

(c) To buy, sell and distribute fuel oil and fuel oil storage tanks and to buy, sell and install oil burners and oil furnaces of every kind and nature.

(d) To construct and erect buildings or structures upon and to improve and maintain any and all real property owned, leased or held by this corporation; and to equip, improve and generally operate any and all personal property owned by this corporation.

(e) To purchase, hold, sell and transfer the shares of its own capital stock; provided, it shall not use its funds or property for the purchase of its own shares of capital stock when such use would cause any impairment of its capital; and provided further that the shares of its own capital stock owned by it shall not be voted upon directly or indirectly.

(f) To enter into, make, perform and carry out contracts of every sort and kind which may be necessary or desirable for the furtherance of the business of this corporation, with any persons, firms, corporations, associations, any state, territory, or municipality of the United States or any foreign country, government or body politic.

(g) To acquire, and hold all or any part of the capital stock, assets, or good will of any business, or any person, firm, association or corporation engaged in any business in whole or in part similar to that of this corporation, consistent with the objects and purposes of this corporation, and to hold, utilize assets, good will and rights so acquired and to conduct in any lawful manner in whole or in part any business so acquired, and to undertake or assume the whole or any part of the obligations or liabilities of any person, firm, association or corporation engaged in the business so acquired.

(h) To borrow money for any purpose of this corporation, without limit as to amount, and to issue bonds, debentures, notes or other evidences of indebtedness, secured or unsecured, of this corporation for the moneys so borrowed, or in payment for property

1 acquired, or for any other objects or purposes of this corporation,  
2 or in connection with its business; to secure payment of such  
3 debentures, notes or other obligations by mortgages or pledges or  
4 other liens upon any or all of the property of this corporation  
5 wherever situated.

6 (i) To carry out all or any part of the foregoing objects,  
7 or purposes as principal or agent, or otherwise, either alone or  
8 in conjunction with any person, association or other corporation  
9 and in any part of the world; and in carrying on its business and  
10 for the purpose of attaining or furthering any of its objects or  
11 purposes, to make and perform such contracts of any kind and des-  
12 cription, to do such acts and such things and to exercise any and  
13 all such powers as a natural person could lawfully make, perform,  
14 do or exercise, provided that the same be not inconsistent with  
15 the objects or purposes of this corporation, or the statutes of  
16 the State of Idaho.

17 (j) To conduct its business in all or any of its branches  
18 in the State of Idaho, and in any and all other states, territories,  
19 possessions, colonies and dependencies of the United States of  
20 America and in the District of Columbia, and in any or all foreign  
21 countries, and to have one or more offices within or outside of  
22 the State of Idaho.

23 (k) The objects as specified herein shall, except as  
24 otherwise expressed, be in no way limited or restricted by refer-  
25 ence to or inference from the terms of any other clause or para-  
26 graph of these Articles. The objects, purposes and powers specified  
27 in each of the clauses or paragraphs in these Articles shall be  
28 regarded as independent objects, purposes and powers.

29 The foregoing shall be construed as objects and powers  
30 and the enumeration thereof shall not be held to limit or restrain  
31 in any manner the general powers now or hereafter conferred on this  
32 corporation by the statutes of the State of Idaho.

### III.

The period of existence and the duration of the life of  
this corporation shall be perpetual.

### IV.

The location and postoffice address of the registered  
office of this corporation in the State of Idaho shall be Nampa,  
in the County of Canyon, State of Idaho.

### V.

This corporation is authorized to issue one class of  
shares of its capital stock to be designated as common stock;  
the total number of shares of common stock which this corporation  
shall be authorized to issue is 500. The aggregate par value of  
the capital stock of this corporation shall be \$50,000.00; and the  
par value of each of said shares of common stock shall be \$100.00.

### VI.

The names and postoffice addresses of each of the incor-  
porators of this corporation and the number of shares of said  
common capital stock subscribed by each of these incorporators

The capital stock of this corporation shall be non-assessable; and the private property of the shareholders in this corporation shall not be liable for the debts, obligations or liabilities of this corporation .


VIII.


A director of this corporation shall not be required to be a holder of any of the shares of the common capital stock of the corporation.


