#### ARTICLES OF INCORPORATION

OF

BENEWAH COUNTY SENIOR CITIZENS, INC.

know all Men by These Presents, that we the undersigned citizens of the United States of America, being each of full age, and being members of Benewah County Senior Citizens, Inc., St. Maries, Idaho, have this day voluntarily associated ourselves together for the purpose of forming a non-profit social and benevolent corporation under and pursuant to the laws of the State of Idaho, and we do hereby certify the following to be the Articles of Incorporation thereof.

#### ARTICLE I.

The name of this Corporation shall be BENEWAH COUNTY SENIOR CITIZENS, INC.

#### ARTICLE II.

The purposes for which this Corporation is formed are as follows:

- (a) To promote the social, recreational, educational and economic development of the membership of said corporation and of all senior citizens residing or being within Benewah County, Idaho and adjacent areas.
- (b) To encourage, promote and develop, in cooperation with local, state and federal agencies, both public and private, a comprehensive program for the benefit and general welfare of all senior citizens within said areas.
- (c) To have and exercise all of the powers and authorities and to engage in all activities now or hereafter allowed by law to non-profit corporations of this

state, with particular emphasis upon, but not necessarily limited to the promotion and encouragement of the interests of senior citizens.

### ARTICLE III.

This Corporation shall have perpetual duration.

#### ARTICLE IV.

The location and post office address of the registered office and principal place of business of this Corporation shall be St. Maries, Benewah County, Idaho, and the Corporation may have such other offices and places of business within or outside the State of Idaho as the directors shall, from time to time determine.

#### ARTICLE V.

The authorized capital of this Corporation shall be One Thousand and no/100 Dollars (\$1,000.00), represented by two thousand (2,000) membership certificates of the value of Fifty Cents (50¢) each, which membership certificates shall be available to all persons meeting the qualifications for membership set forth in the bylaws of this Corporation, the rights and interests of all members to be equal.

#### ARTICLE VI.

The name and post office address of each of the incorporators of this Corporation are as follows:

#### ARTICLE VII.

Each certificate of membership of this Corporation shall entitle the holder thereof to one vote at all meetings of members of the Corporation, and shall not be transferable except in accordance with the provisions of the Corporation's bylaws, and shall be subject to such other restrictions relating to payment of annual dues, attendance of meetings and participation in the affairs of the Corporation as the bylaws may provide; and no dividends, interest or other distribution of any assets of the Corporation shall be paid or distributed to any holder of such a certificate.

#### ARTICLE VIII.

This Corporation does not contemplate pecuniary gain or profit to the members thereof or to the Corporation, and it is organized solely for non-profit social and benevolent purposes; any and all assets of the Corporation are irrevocably dedicated to the purposes herein stated; and upon liquidation, dissolution, disbanding or abandonment, after providing for the debts and obligations of the Corporation, any remaining assets will not inure to the benefit of any private person but will be distributed to a non-profit fund, foundation or corporation which is organized and operated for charitable or benevolent purposes and which has established its tax exempt status under the Internal Revenue Code.

#### ARTICLE IX.

The undersigned incorporators and the undersigned officer of this Corporation hereby certify that a meeting of the members of said Corporation was held on Thursday,

April 1, 1971, at St. Maries, Idaho, at 1:00 P.M., in the V. F. W. Hall, St. Maries, Idaho, pursuant to prior notice thereof published for two weeks in the St. Maries Gazette Record, a newspaper published in St. Maries, Benewah County, Idaho, all as required by the provisions of Idaho Code, Section 30-1102; and they do further certify that the following named individuals were elected to serve as directors of said Corporation by a vote of the majority of the members present at such meeting:
