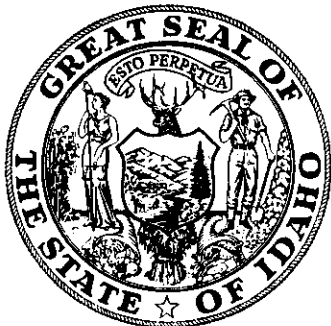

ARTICLES OF DISSOLUTION

In compliance with the applicable provisions of Chapter One of Title Thirty of the Idaho Code, including Sections 31-1-83, 31-1-84, and 31-1-87, Red Top Farms, Inc., an Idaho corporation, hereby adopts the following Articles of Dissolution, executed, in duplicate, by its president and secretary:

(a) The name of the Corporation is Red Top Farms, Inc. and its address is 12350 North Philbin Road, Pocatello, Idaho 83202.


