ARTICLES OF INCORPORATION

SECRETARY OF STATE

STATE OF IDAHO The name of the corporation is **Christian Chaplaincy Mission International, Incorporated.**

II. This corporation shall a non-profit corporation.

- A. Dispersing of all funds will be expressly for the intended purposes as expressed in Article IV.
- B. Upon dissolution of this corporation, all assets will be distributed to an other organization or organizations, organized for the same purposes as expressed in Article IV.

III. The duration of this corporation is perpetual.

IV. The purpose of the corporation is as follows:

- A. To establish, promote, operate, charter or otherwise provide for Christian missions, both domestic and foreign: especially, but not limited to, those endeavors that minister to the needs of the poor, the indigent, the sick and the incarcerated.
- B. To educate, train, license and ordain Christian ministers and chaplains.
- C. To operate places of Christian worship, service and education.
- D. To produce and distribute Christian materials and literature for the purpose of education, encouragement and enrichment of the individual, family and community.

V. The non-profit corporation is to have a non-voting membership. The name and address is: **Christian Chaplaincy Mission International, P.O. Box 1039, Twin Falls, Idaho, 83301-1039.**

- A. A governing body (Board of Directors) of Senior Chaplain and, Elders and Deacons has the authority to elect trustees and officers and appoint committees, conferences and councils as needed.
- B. The governing body of Senior Chaplain, Elders and Deacons (directors) retains to itself exclusive right to self government in all phases of the spiritual and temporal life of the ministry, mission and corporation.
- C. The Senior Chaplain has veto prerogative on all matters.
- D. The membership will be non-voting.
- F. Replacements or additions to the Board of Directors will be made by appointment of the simple majority of the board members.



VI. Discipline: It shall be the practice of this ministry and its missions to conduct its business and resolve troubles by the application of the Holy Scriptures as represented in the Old and New Testaments of the Bible. Should some situation exist that by the conduct of any member or leader, harm to the organization or its members or the cause of Christ may result or has resulted, or by that conduct or action violate Biblical principles, every effort shall be made to restore that individual to full communion with the Lord and the brethren. Should restoration through repentance, confession, restitution or other appropriate Biblical means prove unattainable, exclusion from the ministry, its missions and fellowships may result, with the door of restoration remaining open.


