### ARTICLES OF INCORPORATION

OF

( a professional Corporation )

LET IT HEREBY BE KNOWN that the undersigned for the purpose of forming a professional corporation under the Idaho Business Corporation Act, Title 30, Chapter 13, IDAHO CODE does herein certify, declare and adopt the following ARTICLES OF INCORPORATION:

1.

THE NAME of the Corporation shall be GEM REHABILITATION SERVICES. P.C.

THE NATURE of the business, or the object or purpose to be transacted, promoted, or carried on by the Corporation is:

> 1. To provide physical therapy and other physical development activities as prescribed under Idaho licensing jurisdiction.

THE AGGREGATE NUMBER of shares which the Corporation shall have the authority to issue is TEN THOUSAND (10000) shares of no par value common stock. Said shares shall constitute one class only.

THE CORPORATION is to have a perpetual existence.

THE BUSINESS of the Corporation shall be managed by its Board of Directors, each of whom shall be at least eighteen (18) years of age. The number of Directors of the Corporation shall be setforth in the Bylaws in a manner not prohibited by law. Until so changed, the number of Directors shall be (1). The Directors need not be residents of the state, but must be shareholders of the corporation and licensed as professionals under the laws of Idaho.

VI.

THE PRIVATE PROPERTY of the shareholders shall not be subject to the payment of Corporate debts.

## VII.

THE CORPORATION SHALL have the authority, in accord with Idaho State law, to indemnify each Director or Officer, or any person who may have served at it's request as a Director or Officer of another corporation in which it has shares of stock or of which it is a creditor, against actual and necessary expenses incurred by him in connection with the defense of any action, suit, or proceeding in which he is made a party by reason of being or having been a Director or Officer of the Corporation or of such other corporation (whether or not he continues to be a Director or Officer at the time of incurring such expense) except in relation to matters as to which he shall be adjudged in such action, suit, or proceeding to be liable for negligence or wilfull misconduct in the performance of his duty as such Director or Officer. Such indemnification shall not be deemed exclusive of any other rights to which those indemnified may be entitled under any Bylaw, agreement, vote of Shareholders, or otherwise.

THE CORPORATION SHALL have the right to defend and to incur reasonable expenses in the defense on any such actions, suits, or proceedings brought against any such Director, Officer, or person. Wherever in this Section a Director or Officer is referred to, such reference shall include his or her personal representatives, executors and administrators.

### VIII

MEETINGS of the Shareholders may be held outside the State of Idaho if the Bylaws so provide. Subject to any provision contained in the Statute, books of the Corporation may be kept outside the State of Idaho at such place or places as may be designated from time to time either by the Board of Directors or in the Bylaws of the Corporation. Election of Directors need not be by ballot unless the Bylaws of the Corporation shall so provide.

IX.

THE CORPORATION reserves the right to amend, alter, change, or repeal any provision herein contained in the manner now or hereafter prescribed by statute and all rights conferred upon the Shareholders herein are granted subject to the reservation.
