ARTICLES OF INCORPORATION

10 24

OF

CRANSTON EIXENBERGER ARCHITECTS P.A.

The undersigned, each of whom is duly licensed to practice the profession as an architect in the State of Idaho, desire to form a professional corporation pursuant to the provisions of Chapter 13, Title 30, Idaho Code, for the purposes of rendering architectural services and adopt the following Articles of Incorporation for such corporation:

Ι

NAME. The name of the corporation shall be CRANSTON EIXENBERGER ARCHITECTS P.A.

II

PURPOSES. The purposes for which the corporation is formed is to engage in the general practice of the professional of architecture.

III

GENERAL POWERS. To have, own, possess and exercise all lawful business for which such corporation may act under and pursuant to the provisions Chapter 13, Title 30, Idaho Code, and pursuant to Section 30-1312, Idaho Code.

To have and possess those general powers of a corporation as are provided by Section 30-1-4, Idaho Code, not in conflict therewith.

IV

PERIOD OF DURATION. The period of duration for such corporation shall be perpetual.

V

CAPITAL. The capital of said corporation shall be the amount of \$5,000.00 which shall be represented by an aggregate number of shares authorized to be issued by the corporation of five, each having a par value of \$1,000.00 each.

The corporation shall not issue any stock except common stock, all having, owning and possessing equal rights, including voting rights.

All shares of stock issued shall be in conformity with the provisions of Section 30-1308, Idaho Code.

BOARD OF DIRECTORS. The number of directors constituting the initial Board of Directors shall be two in number, they being:

John T. Eixenberger 105 Idaho Street Rathdrum, Idaho 83858.

The Board of Directors of said corporation shall have by majority vote the power to adopt bylaws of said corporation and to amend the same from time to time.

ΙX

Pursuant to the provisions of Section 1372A of Internal Revenue Code, the corporation shall be treated and shall exist as a Small Business Corporation with the restrictions that are applicable thereto and shall have its income taxed directly to its shareholders, whether distributed to them or not.

Х

COMMENCEMENT OF BUSINESS. The corporation shall not commence business until it has been duly authorized by the adoption of these Articles of Incorporation and the issuance of a Certificate of Authority from the Secretary of State of the State of Idaho, and in no event, prior to January 1, 1986.
