ARTICLES OF INCORPORATION

KNOW ALL MEN BY THESE PRESENTS, that the undersigned, being a person of legal age, does this day act for the purpose of forming a corporation under and pursuant to the laws of the State of Idaho, and to that end hereby adopts Articles of Incorporation as follows:

The nature of the business of the corporation and the objects to be transacted, promoted, or carried on by it are:
