Pursuant to Title 30, Chapter 1, Idaho Code, the undersigned corporation amends its articles of incorporation as follows:

1. The name of the corporation is Health Ventures Corporation.
2. The text of each amendment is as follows:

Article IV of the Articles of Incorporation of the corporation is hereby amended in its entirety to read as follows:

IV.

The purposes for which this corporation is organized shall be and are to transact insurance, including but not limited to disability insurance and the transaction of a managed care plan business, and to transact any other lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

Article VI of the Articles of Incorporation of the corporation is hereby amended in its entirety to read as follows:

VI

The aggregate number of shares that this corporation shall have the authority to issue shall be one million (1,000,000) shares of nonassessable voting common stock with \$1.00 (One Dollar) per share par value.


