ARTICLES OF INCORPORATION

OF

CY'S MEATS, INC.

KNOW ALL MEN BY THESE PRESENTS, that we, the undersigned, being residents of and citizens of the United States of America, of legal age, and all of whom are domiciled in and residents of the State of Idaho, do by this agreement associate ourselves together for the purpose of forming a corporation under the laws of the State of Idaho, and we do hereby certify as follows:

I.

That the name of this corporation shall be CY'S MEATS, INC.

II.

The purpose of this corporation is to operate a business of buying, selling and dealing in meats of all kinds, game and poultry, for human consumption, both live and dressed, retail and wholesale, slaughtering meat animals for human consumption, processing, dressing, curing, smoking and preparing all kinds of meat for sale, including poultry and fish, and distributing the same. To merchandise, sell, offer for sale and distribute at wholesale and retail, foods and foodstuff of all kinds and descriptions, whether in bulk, packages or cans, including beverages of all kinds for all purposes, and to generally deal in groceries and grocery products suitable for public consumption. To own, operate, run and manage a retail and wholesale store and to own and/or lease real estate, buildings, fixtures and all necessary machinery and appliances

for running and operating a general merchandising business for the purposes of selling, manufacturing, packing and preserving foods of all kinds and their by-products and to own, operate and manage a cold storage locker business and to do all and everything necessary, suitable and proper for the accomplishment of any of the purposes or any of the objectives, or the furtherance of any of the powers herein set forth, either alone or in association with other corporations, firms or individuals, and to do every act or acts, thing or things pertinent or growing out of, or connected with the objectives or purposes, or any part thereof, provided herein, insofar as the same shall not be inconsistent with the laws of the State of Idaho under which this corporation is formed.

III.

That the duration of this corporation shall be perpetual.

IV.

The total authorized number of par value shares is 100,000. The aggregate par value of the total authorized number of shares is \$100,000.00.
