## ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF ADVANCED INPUT DEVICES, INC. (Pursuant to Section 242)

The undersigned officers, on behalf of ADVANCED INPUT DEVICES, INC., a Delaware corporation authorized to do business in Idaho, do hereby execute and deliver to the Secretary of State Articles of Amendment to the Articles of Incorporation of the corporation.

- 1. The name of the corporation is ADVANCED INPUT DEVICES, INC.
- 2. Article FOURTH of the Articles of Incorporation shall be changed so that, following that change, Article FOURTH shall read as follows:

FOURTH. The stock in the corporation shall be in two classes which be denominated Class A and Class B. The shares of both classes shall have no par value. The corporation shall have authority to issue 1,000 shares of Class A common stock and 19,000 shares of Class B common stock. Class A shares and Class B shares shall be identical in all respects except that (1) Class B common shares shall not have the right to vote and 2) for purposes of conversion and determining relative rights, one Class A common share shall be equivalent to 100 Class B common shares.

- 3. The above Amendment was adopted by unanimous vote at a duly convened meeting held on September 24, 1980.
- 4. Eight hundred thirty (830) Class A common shares were outstanding and entitled to vote upon the Amendment. None were entitled to vote as a class. All eight hundred thirty (830) shares were voted in favor of such Amendment.
- 5. The Amendment does not provide for an exchange, reclassification, or cancellation of issued shares. However, the Amendment does increase from two thousand (2,000) to twenty thousand (20,000) the number of no-par common shares which the corporation is authorized to issue.
