5. The address of its principal office in the state or country under the laws of which it is incorporated is 7330 San Pedro, Ste. 476, San Antonio, Texas 78216

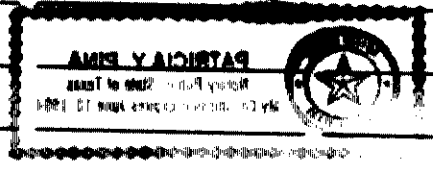

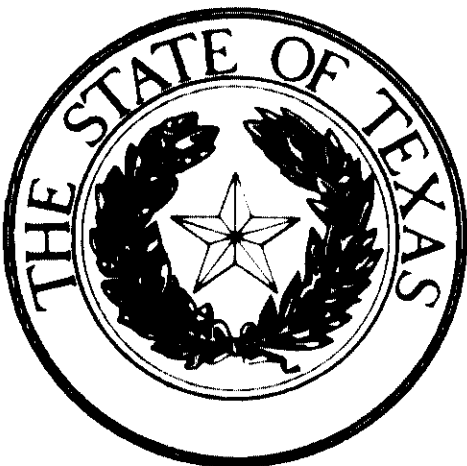
