

KNOW ALL MEN: That we, the undersigned, delegates to the Southern Idaho Conference of Seventh Day Adventists, have this day voluntarily associated ourselves together for the purpose of incorporating under and in accordance with the provisions of Chapter VIII, Title IV, Part Second of the Revised Statutes of the State of Idaho, 1887, and in pursuance of the purposes for which trustees have been elected, as hereinafter set forth, a religious corporation to be known as The Southern Idaho Conference Association of Seventh Day Adventists.

And we certify that the objects for which this corporation is formed are: To establish and conduct churches, schools, sanitariums and hospitals and like and similar charitable institutions and to aid and assist in the establishment and conduct of the same and, in connection with the above mentioned institutions, to establish and conduct and assist in establishing and conducting suitable and customary organizations ~~for the purpose of public worship and religious training, according to the~~ rules and discipline of the said Society of Seventh Day Adventists; to acquire, hold, mortgage and convey all necessary and proper property, both real and personal, for the purposes above set forth; to receive legacies and devises and to act as executor, administrator and guardian and trustee under deeds and wills; and to perform and do each and every necessary and proper act for the purpose of making the foregoing enumerated rights and powers effective.

That the principal place of business of this corporation shall be at Boise City, County of Ada, State of Idaho, but Conference Meetings and Elections of Trustees may be held at any other place in the State of Idaho, that may be designated by the trustees of this corporation.

That the term of the incorporation shall be fifty years.

That the membership of this corporation shall be unlimited in number and shall be composed of the delegates duly elected to the Southern Idaho Conference of Seventh Day Adventists as by the rules and regulations of said society of Seventh Day Adventists provided, and said delegates shall remain members of said corporation until their successors are elected and qualified as by the rules and regulations of said society of

Seventh Day Adventists provided.

That the number of trustees who shall have the management of its affairs as aforesaid shall be three, and the names of the trustees elected for the first year are:

That the said trustees were duly elected at a meeting of the members of said Conference held in the City of Weiser, County of Washington, State of Idaho, on the 21st day of July, 1907, for the purpose, among other things, of electing trustees to take charge and management of its property, temporalities, and affairs, and to form this incorporation. That a majority of said members were then and there present, and voted, at such election, for the above named trustees, as is more particularly set forth in the certificate and verification by the officers who conducted the election, hereto annexed and made a part of these articles.
