KNOW ALL MEN BY THESE PRESENTS, that we, the undersigned, all being citizens of the United States of America and of full legal age, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho, and to that end do hereby adopt articles of incorporation and do hereby certify in writing as follows:

That the name of the corporation shall be COMPONENT SALES. INC.

That the principal office and the place where the business of the corporation is to be transacted is, and the post office address of said business is as follows:

That the term for which the corporation is to be in existence shall be perpetual.

That the number of directors of said corporation shall be three [3].

That the purposes for which said corporation is to be formed are as follows:

To engage in the business of promoting, selling and distributing component homes and other component buildings and component parts thereof, both in and outside of the State of Idaho.

To act as agent for such persons, firms, associations and corporations as shall employ it to promote, sell and distribute said component homes, component buildings and parts or parcels thereof, and all materials and appliances and other personalty used in connection therewith

To purchase, improve, develope, lease, exchange, sell, dispose of, mortgage, hypotecate and otherwise deal in and turn to account, any and all real and personal property; to purchase, lease, build, construct, erect, occupy and manage, lease and hypotecate buildings of every kind and character whatsoever; to finance the purchase, improvement, developement and construction of land and buildings belonging to, to be acquired by this company or by any other person, firm, or corporation.

To do a general business as commission merchant, selling agent, and factor under del credere commission in the manner and to the same extent as natural persons could do

To make and enter into all kinds of contracts, agreements and obligations by or with any person or persons, corporation or corporaations, for the purchasing, acquiring, holding, manufacturing and selling or otherwise disposing of, either as principal or agent, upon commission or otherwise, all goods, wares, and merchandise within the Inited States.

To carry on and undertake any business, undertaking, transe action, or operation commonly carried on or undertaken by merchants, commission men, factors, importers, and manufacturer's agents, and in

To generally engage in, do and perform any enterprise, act or vocation that a natural person might or could do or perform.

The purposes herein specified shall be construed both as pruposes and powers and shall be in no wise limited or restricted by reference to, or inference from, the terms of any other clause in this or any other article, but the purposes and powers specified in each of the clauses herein shall be regarded as independent purposes and powers, and the enumeration of specific purposes and powers shall not be construed to limit or restrict in any manner the meaning of general terms or the general powers of the corporation; nor shall be expression of one thing be deemed to exclude another, althoug it be of like nature not expressed
