That I, the undersigned, being a citizen of the United States of America, and a being person of full legal age, have this day voluntarily formed a domestic corporation under and pursuant to the laws of the State of Idaho, and do hereby certify as follows:

**FIRST:** The name of this corporation shall be E-O-B, Inc.

**SECOND:** The purposes for which this corporation is formed are as follows:

A. To engage in any lawful business activity for which corporations may be organized under the laws of the State of Idaho including, but not limited to, a general construction and contracting business.


