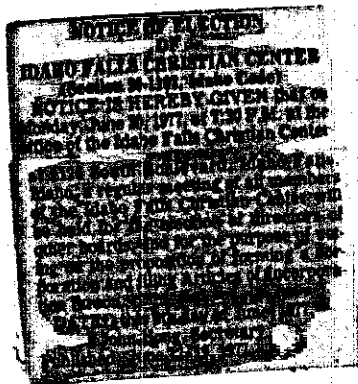

ARTICLE I

The name of the corporation shall be the Idaho Falls Christian Center, Inc. The address of the corporation is 1122 South Boulevard, Idaho Falls, Idaho 83401.

ARTICLE II

The purpose of the corporation shall be to be a church which propogates the Gospel of Jesus Christ, to provide interfaith places of worship, to conduct classes for religious education and instruction and to generally perform, promote and assist religious and charitable work for the church and the public welfare.

ARTICLE III

The officers of the corporation shall consist of a president and board of directors. The directors shall be elected per Section 30-1101, Idaho Code. There shall be a minimum of three directors. One of the directors shall act as secretary-treasurer. The office of president shall be a permanent office vacated only by death or resignation.

ARTICLE IV

There shall be an annual meeting of membership per Sections 30-133 and 30-161, Idaho Code. Special meetings may be called by the president or board of directors. Three or more officers of the corporation shall constitute a quorum.

ARTICLE V

The duration of the corporation shall be perpetual or until dissolved by a meeting of the membership. If the corporation is dissolved, the board of directors shall, after paying or making provision for the payment of all liabilities, dispose of all assets and determine the disposition of any remaining funds.

ARTICLE VI

The rejection of any of the following shall be grounds for ineligibility to the office of president or board of directors:

1. We believe in one God in three persons of the Father, Son and Holy Spirit.
2. We believe the Bible in its entirety to be the inspired Word of God and the only infallible rule of faith and conduct.
3. We believe that Jesus Christ died for our sins and rose again for our justification.
4. We believe in the soon-coming personal return of the Lord Jesus Christ.
5. We believe the baptism of the Holy Spirit is available to all Christians.

ARTICLE VII

Recognition will be given to Cliff and Helen Beard for the duration of this corporation by acknowledging their apostolic ministry and as the founders of the Christian Center. In support of the ministry of Cliff and Helen Beard, offerings may be given to them. However, this is to be determined by the governing oversight.


