ARTICLES OF AMENDMENT

TO THE ARTICLES OF INCORPORATION C 5. 11 185 SECRETARY IT STATE

OF

NORTH SIDE CANAL COMPANY

Pursuant to the provisions of \$30-1-61 of the Idaho Business Corporation Code, and Idaho Code \$42-2401 (6.), the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST:

The name of the corporation is North Side Canal Company, Limited.

SECOND:

the Articles The following Amendments to Incorporation were adopted by the shareholders at the annual shareholders' meeting duly called and noticed for the purpose of voting on proposals to amend the Articles and By-Laws of the corporation on January 15, 1985, at the offices of the Company at 921 North Lincoln Avenue, Jerome, Idaho, in the manner prescribed by the Idaho Business Corporation Act and Idaho Code §42-2401.

That Article Second of the Articles of Incorporation be amended by the addition of the following at the end of said Article Second.

To acquire real property and personal property a
necessary: to construct dams, reservoirs, canals
headworks, diversions, penstocks, generating
facilities, and transmission lines, including an
other appurtenant facilities necessary for the
construction, operation and maintenance of
hydroelectric facilities in Jerome, Gooding, Elmore
and Twin Falls Counties, Idaho; to do all thing
necessary to finance said facilities including
executing debt instruments and assignments necessar
to secure said financing; to enter leases, join
ventures, or legal entities of any kind to facilitat
the financing and construction of said hydroelectri
projects; provided that no liens shall be imposed of
the lands of the stockholders; and further provide
that the lands, water rights, irrigation facilities

and equipment owned and used by the Company in the delivery of irrigation and stock water to stockholders shall not be mortgaged, pledged, assigned or encumbered in any way as collateral or security for any debt incurred in financing, constructing, operating and maintaining said hydroelectric facilities if said mortgage, pledge, assignment or encumbrance in anyway impedes the delivery of water to stockholders.

It is hereby expressly declared that all other lawful powers, not inconsistent with the purposes set out in these Articles of Incorporation, are hereby authorized.

THIRD:

The number of shares of the corporation outstanding at the time of such adoption was 149,334.62 and the number of shares entitled to vote thereon was the same.

FOURTH:

The number of shares voted for the amendment of Article Second was 17.111.172; and the number of shares voted against such amendment was 352.80
