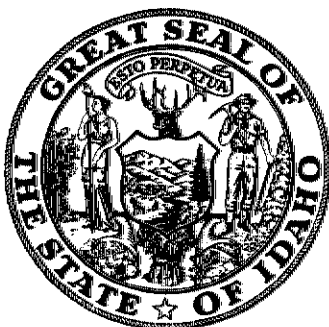

**ARTICLES OF INCORPORATION  
OF  
SHADOW MOUNTAIN FRAMING, Inc.**

The undersigned, in order to form a corporation pursuant to Idaho Business Corporation Act  
certify as follows:

**ARTICLE I**

The name of the corporation is Shadow Mountain Framing, Inc. (hereafter "Corporation").

**ARTICLE II**

The purpose for which this Corporation is organized are as follows:

1. To engage in Framing & Siding houses; and
2. To engage in any other lawful activity or business for which corporations may be incorporated under the Idaho Business Corporation Act.
