THE UNDERSIGNED, IN ORDER TO FORM A CORPORATION UNDER THE PROVISION OF IDAHO CODE TITLE 30, CHAPTER 1, SUBMITS THE FOLLOWING ARTICLES OF INCORPORATION TO THE IDAHO SECRETARY OF STATE:

**ARTICLE ONE
NAME**

The name of the Corporation is HILLMONDO, INC.

**ARTICLE TWO
AUTHORIZED SHARES**

The Corporation is authorized to issue a single class of stock which shall be designated common voting stock. The aggregate number of shares the Corporation is authorized to issue shall be one thousand (1000) shares. There shall be no par value established with regard to the individual shares of stock.

**ARTICLE THREE
REGISTERED OFFICE AND AGENT**
