
**CERTIFICATE OF INCORPORATION

ARTICLES OF INCORPORATION

The undersigned, acting as incorporators of KCM, INC., a corporation under the Idaho Business Incorporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is KCM, INC.

SECOND: The period if its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are:

(a) To operate one or more convenience stores and to lease, buy, and sell, at both wholesale and retail, on its own or on commission or as a factor, all types of groceries, meats, dairy products, novelties, petroleum products, automotive parts and supplies, newspaper and magazines, video tapes, and all other types of retail merchandise which may be dealt with profitably.

(b) To carry on any other kind of business or business activities that the Board of Directors may from time to time deem to be advisable or proper in connection with the business.

(c) To purchase, lease, own, sell, mortgage, sublease, and otherwise acquire lands, buildings, easements or property, real and personal, which may be requisite for the purposes or are capable of being conveniently used in connection with any of the objects of this corporation, and to enter into, make, perform and carry out contracts of every sort and kind with any person, and

to acquire and take over the good will, property, rights, franchises, and assets of every kind and the liabilities of any person, firm, association, or corporation, either wholly or in part, and to pay for the same in cash, stocks, or bonds of the corporation, or otherwise.

(d) To transact any and all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is:


