




**CERTIFICATE OF INCORPORATION

ARTICLES OF INCORPORATION

THESE PRESENTS PRESENT WITNESSETH:

WILLIAM T. ADMIRE, who is over eighteen (18) years of age, acting as incorporator of a corporation under the laws of the State of Idaho, adopts the following ARTICLES OF INCORPORATION for such Corporation:

ARTICLE I

The name of the Corporation is KOOTENAI TRANSPORT, INC..

ARTICLE II

The period of duration of the Corporation is perpetual.

ARTICLE III

The purpose of the Corporation is to engage in any and all business, the conduct of which is not forbidden to corporations by state or federal law.

ARTICLE IV

The aggregate number of shares which the Corporation shall have authority to issue is one hundred thousand (100,000) shares of common stock, all of which are without par value.

Capital stock may be issued by the Corporation from time to time for such consideration, including, without limitation, services, money or property as may be fixed by resolution of the Board of Directors from time to time.

ARTICLE V

ARTICLE VI

The number of directors constituting the initial Board of Directors of the Corporation is three (3). Thereafter, such number shall not be less than three (3) as may from time to time be specified in the bylaws. The persons who are to serve as Directors until the first annual meeting of shareholders and until their successors are elected and qualified, are:

ARTICLE VII

The power to adopt, alter, amend or repeal the bylaws or adopt new bylaws shall be vested in the Board of Directors.

ARTICLE VIII

The Corporation reserves the right to amend, change or repeal any provision of the ARTICLES OF INCORPORATION in the manner now or hereafter prescribed by law, and all rights conferred upon shareholders herein are subject to this reserved power. Any contract, transaction, or act of the Corporation or of the Directors or of any Officers of the Corporation which shall be ratified by a majority of a quorum of the shareholders of the Corporation at any annual meeting or any special meeting called for such purpose, shall insofar as permitted by law, be as valid and as binding as though ratified by every shareholder of the Corporation.

ARTICLE IX


