

Certificate of Incorporation
of
The Paris Co-operative Tannery.

Be it known by these presents; That we Christian Hallantine, John A. Sutter, Harley Morrey, George Osmund, John Walker, Daniel Jacobs, and John A. Hunt all residents of Bear Lake County, Idaho Territory, in accordance with an act of the Legislative Assembly of the Territory of Idaho, entitled "An Act concerning Corporations" Approved January 13th A. D. 1875, and in consideration of the conditions there in mentioned, do hereby mutually agree, each with the other and with our associates and successors, to enter into and form an association or body corporate for the purposes and subject to the provisions, herein set forth viz:

1 The corporate name of this Corporation is and shall be the Paris, Co-operative Tannery.

2 The principal place of business is the Town of Paris, County of Bear Lake & Territory of Idaho.

3 Its object the manufacture of Leather
Boots, Shoes and Harness.

4 The Capital Stock shall be Ten Thousand
dollars, divided into Two Thousand
shares of Five dollars each.

5 This Corporation shall continue for ten
years from the 20th day of March A. D.
1876.

6 There shall be seven Trustees of the
Corporation, elected annually to manage
the concerns of the Company, and the
following named shall be Trustees
for the first three months; viz:

Christian Wallantine, John A. Suttan
and Harley Mowrey of Paris, George
Osmond and John Walter of Bloomington
John A. Hunt and Daniel Jacobs of
St. Charles.
