That we, the undersigned, being all of lawful age, citizens of the United States of America, do, under and in pursuance of the general corporation laws of the State of Idaho, and particularly Section 30-301, et seq., Idaho Code, hereby organize, constitute and associate ourselves and such other persons as may hereafter become associated with us, for the purpose of forming a non-profit corporation under the laws of the State of Idaho, and we do hereby adopt and certify the following ARTICLES OF INCORPORA-TION, and we hereby set forth and declare as follows:

ARTICLE I.

That the name of this corporation shall be MOSCOW DOWNTOWN ASSOCIATION, INC.

ARTICLE II.

That the location and post office address of the registered office in the State of Idaho for the transaction of business of 520 \$. Main main as green many me. this corporation shall be P.O. Box 9041, Moscow, Idaho 83843, and the name of the registered agent at such address is Carolyn Berg

ARTICLE III.

That the duration and term of the existence of this corporation shall be perpetual.

ARTICLE IV.

That in furtherance, and not in limitation of the general powers conferred by the laws of the State of Idaho, this corporation shall have the following objects, purposes and powers:

Promotion of downtown events, activities, sales and attractions.

Promotion and cooperation for area-wide activities and attractions.

Creation of happenings, events and attractions in downtown Moscow.

Liaison between property owners, merchants, professionals and others involved with the Central Business District. Coordination between the interests of the Central Business District and those of the City, the University of Idaho, the School District, the County and other public, non-profit and private groups.

Coordination of public and private physical development programs in, or affecting, downtown Moscow.

To promote the general welfare of the City of Moscow by advancing the general business climate and customer goodwill and convenience.

This corporation shall never carry on any business, trade, avocation or profession for profit.

To do all things in connection with its objects permitted by law and to exercise any and all powers not prohibited by law as pertains to organizations of this type.

ARTICLE V.

This corporation is not organized for profit and shall have no capital stock, and shall be composed of members with equal voting power rather than shareholders in accordance with the foregoing provisions.

The rights of all members of this corporation shall be equal, and no member shall have or acquire a greater interest therein than any other member.

ARTICLE VI.

The conditions and regulations of membership and the rights and privileges shall be determined and fixed by the By-Laws.

ARTICLE VII.

The private property of the members shall not be subject to the payment of corporate debts, liabilities or obligations to any
