ARTICLES OF INCORPORATION

OF

The undersigned acting as incorporator of a corporation under the Idaho Business Corporation Act adopts the following Articles of Incorporation for such corporation.

ARTICLE I.

The name of the corporation is POINT HAYDEN CO-OPERATIVE ASSOCIATION, INC.

ARTICLE II.

This is a non-profit corporation.

This corporation shall have perpetual duration.

ARTICLE IV.

The purposes and objects for which this corporation is formed are the following:

1. To acquire, manage, maintain and control waterfront and other property

ARTICLE V.

The corporation shall have the following powers:

2. To own, buy, sell, lease, assign, mortgage, hypothecate and by all lawful acts, deal in real and personal property, including the erection and maintenance of buildings and the obtaining of personal property which would further the interests of the corporation.

3. To establish bank accounts, charge dues and fees, solicit money, engage in non-profit enterprises, raise money, hire and fire employees, make loans, acquire loans, deal in choses of action, and engage in any enterprise connected to the purposes herein established in any lawful way, so long as the same are of a non-profit nature.

4. To issue bonds, notes and other instruments of debt and to deal in the stocks, bonds, notes, mortgages and debt instruments of any other person, firm or corporation.

5. To join or merge with any other group, firm, association or corporation, non-profit in nature, whose purposes are not in conflict with those herein stated.

 In the event of dissolution, assets will be distributed to the then existing members.

ARTICLE VI.

This shall be a membership corporation. The membership fees and conditions shall be established by the bylaws. The ownership of any lot in the original Point Hayden subdivision shall entitle the owner and spouse to one membership per each lot owned, subject to the conditions established by the bylaws.
