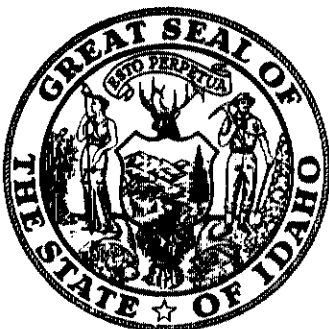
CERTIFICATE OF INCORPORATION OF

ARTICLE I

NAME: The name of the corporation shall be ROCKY MOUNTAIN SNO, INC.

ARTICLE II

PERIOD OF DURATION: The period of duration for this corporation shall be perpetual.

ARTICLE III

PURPOSE: The purpose for which this corporation is organized is the transaction of any and all business for which corporations may be incorporated under the laws of the State of Idaho, as they may be amended from time to time.

ARTICLE IV
