That we, the undersigned, have this day voluntarily associated ourselves that IDAHO for the purpose of incorporating under the laws of the State of Idaho, and in pursuance of the purposes for which we have been elected, as hereinafter set forth, a religious corporation to be known as A Friends Church of Boise.

And we certify:

- I. The name assumed by this corporation, and by which it shall be known, is: Friends Church of Boise.
- П. The object for which this corporation is formed, is – To establish a Church in the City of Boise, in the County of Ada and State of Idaho for the benefit of religion, for works of charity, and for public worship, and in connection therewith, its suitable and customary organizations, such as Sabbath Schools, Christian Endeavors, and so forth - To take charge of the Church and Church Parsonage, and all and singular, the estate, property, and the affairs of the temporalities thereof - and to acquire, hold, lease, contract, sell, convey and dispose of said property, or any part thereof, and to conduct church affairs as set forth in the Northwest Yearly Meeting of Friends Churches, Faith and Practice, a book of Christian Discipline.
