Articles of Incorporation

The undersigned, being duly licensed and qualified to practice physical therapy in the State of Idaho, in order to form a professional corporation for the purposes hereinafter stated, pursuant to the Idaho Professional Service Corporation Act and the Idaho Business Corporation Act, hereby adopts the following Articles of Incorporation for such Corporation.
