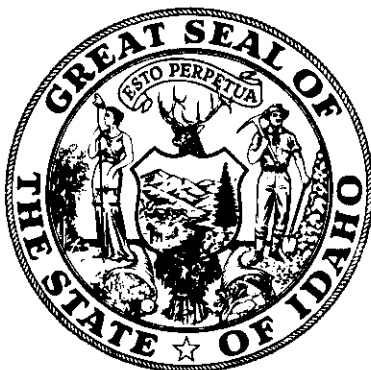

ARTICLES OF INCORPORATION

OF

LEHTOLA AND LEHTOLA ENTERPRISES, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is Lehtola and Lehtola Enterprises, Inc.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are: the transactions of any or all lawful business for which corporation may be incorporated under the Idaho Business Corporation Act including but not limited to the manufacture, marketing, direct sale and mail solicitation sale of manufactured goods.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is One Hundred (100). Par value of each share shall be \$10.00.

FIFTH: Provisions for the regulation of the internal affairs of the corporation shall be governed by By-Laws adopted by the corporation.

SIXTH: The address of the initial registered office of the corporation is Route 2 Box 707, Grangeville, Idaho and the name of its initial registered agent at such address is Larry Lehtola.

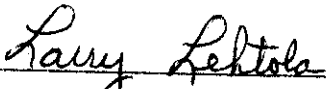

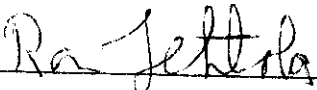

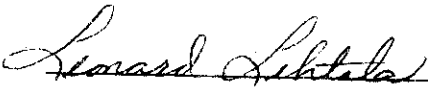
