ARTICLES OF INCORPORATION

OF

N. A. F. OF IDAHO, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

Article I

NAME. The name of the corporation is N. A. F. OF IDAHO, B INC.

Article II

The period of its duration is perpetual. DURATION.

Article III

PURPOSES. The purposes for which the corporation is organized are:

- 13 To conduct and carry on the business of buying, 14 selling, leasing and dealing in all kinds of motor vehicles and all other kinds of goods, wares and merchandise relating thereto, and to 15 do a general commission and brokerage business in any or all of the foregoing kinds of property.
- 2. To engage in the transaction of any or all other lawful business for which corporations may be incorporated under the provisions of Chapter 1, Title 30 of the Idaho Code and any amendments 18 thereto.

Article IV

20 STOCK. The aggregate number of shares which corporation shall have authority to issue is 2,500. Said stock shall 21 be of one class designated as common stock with a par value of \$10.00 per share.

Article V

PREEMPTIVE RIGHTS. There are no provisions denying pre-24 emptive rights.

Article VI

INTERNAL AFFAIRS. There are no provisions for the regulation of the internal affairs of the corporation.

Article VII
