ARTICLES OF INCORPORATION OF THE HANSEN TOWNSITE COMPANY.

KNOW ALL MEN BY THESE PRESENTS, That we, W. H. Browning, William Focht and S. T. Hamilton, all of whom are bona fide residents and citizens of the State of Idaho, have this day voluntarily associated ourselves together, and by these presents do hereby associate ourselves together for the purpose of forming a corporation under and by virtue of the laws of the State of Idaho.

AND WE HEREBY CERTIFY

- I. That the corporate name and style of our said corporation is HANSEN TOWNSITE COMPANY.
- That the purposes for which this corporation is formed are to carry on and conduct in the State of Idaho the general business of a Townsite Improvement and Colonization Association, and particularly to buy and sell lands, improve and cultivate the same, lay out towns and townsites, plat the same into lots, blocks, streets and public places, to sell and otherwise to dispose of, improve and adorn the same, to erect, own, hold, lease, buy and sell stores and dwelling houses and other buildings, to sell and otherwise dispose of the same, to borrow and loan money, with or without security, to induce and assist colonization and immigration, to acquire by purchase or otherwise and to own, hold, develop, sell or otherwise deal in water shares and water rights, corporate stocks and securities and all such other real or personal property as may be convenient in the carrying on of its said business, to acquire by purchase or otherwise and to own and develop power and power rights and to acquire any rights of way which may be necessary in carry-

ing on the business of said corporation, all to the same extent as an individual or individuals may lawfully do in carrying on such transactions.

III. That the operations of our said corporation shall be carried on in the State of Idaho, and it may extend its business to any other state or territory. That the place where its principal business is to be transacted shall be the Town of Hansen, Twin Falls County, Idaho, and branch offices may be located at such places as may from time to time be provided in the bylaws of the Company.
