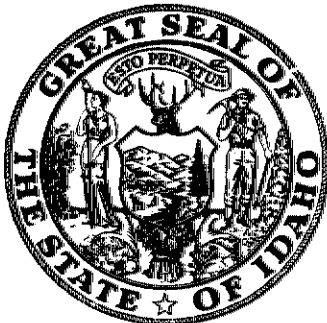

ARTICLES OF INCORPORATION

Of

ALL AROUND SEAMLESS GUTTER CO.

Know all men by these presents: That the undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

I.

The name of the corporation shall be All Around Seamless Gutter Co.

II.

The corporation shall exist in perpetuity.

The aggregate number of shares which this corporation shall have authority to issue shall be 100,000 shares of nonassessable common stock having a par value of \$0.01 per share.

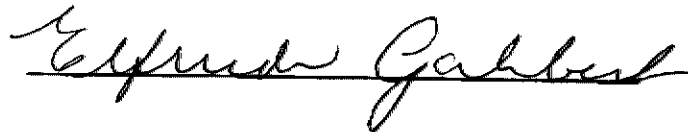

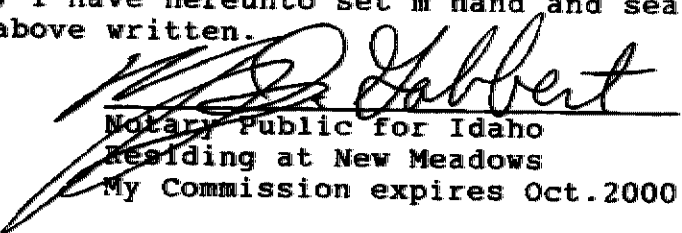
