ARTICLES OF INCORPORATION.

ARTICLE I. THIS CERTIFIES that we the undersigned have this day formed a Company for the purposesofiere inafter mentioned and which shall be known as the ALLIANCE CANAL COMPANY, LIMITED with such powers and privileges as are allowed by law.

ARTICLE II. The object of this Company is to swn, construct, enlarge and control a Canal to conduct water from the BURGESS SWALE at a point about sixty rods west of Frank Storer's dwelling house, it being in the (NE 1/4) North east quarter of Section 20, Township 4 North of Range 39 E. B. M. the said canal to be at least ten feet wide on the bottom at the head and not to exceed fifteen feet on the bottom at the head or along the line of construction except where necessary for dividing headgates or other structural works. The said canal to run due West through the greater portion of sections 20 and 19 a distance of about one & 1/2 miles to and upon land belonging to and owned by Arthur E. Cordon, where the said canal divides into two branches, the main branch continuing in a westerly direction through section nineteen and twenty four to and upon Section 24, Tp. 4 N. R. 38 E, where said canal intersects and empties into the BURGESS SWALE from which it was taken.

The other branch heretofore mentioned runs in a south westerly direction from said Arthur E. Cordons land through and upon Sections 19 Tp 4 N. R. 39 E and across S E corner of Sec. 24 to center of Section 25, both of latter in Ep. 4 N. R. 38 E, over portions of which waters running through said canal are to be distributed.
