ARTICLES OF INCORPORATION

We, the undersigned, being natural persons over the age of eighteen (18), and residents of the State of Idaho, and citizens of the United States of America, in accordance with the laws of the State of Idaho, for the purpose of doing such acts as required for the purposes as hereinafter set forth and to form ourselves into a corporation and body politic under the laws of the State of Idaho for the use and benefit of said TINY TOTS GAMES, INC., have this day voluntarily associated ourselves together for the purpose of forming a corporation under Chapter 3, Title 30, of the Idaho Code, entitled "Idaho Nonprofit Corporation Act," and have adopted the following Articles of Incorporation:

ARTICLE I

The name of this corporation shall be TINY TOTS GAMES, INC.

ARTICLE II

The objects, business and purpose of this corporation are as follows:

(a) To provide games similar to the Special Olympics for children aged eighteen (18) months through six (6) years old who attend the Adult/Child Development Center in Coeur d'Alene, Idaho as well as children participating in other programs for the developmentally disabled in the area of North Idaho.

(b) To demonstrate, from time to time, through organized games, the progress of said developmentally disabled children have made, physically, socially and intellectually.

(c) To perform any lawful act necessary or advisable in furtherance of the corporation.

ARTICLE III

The existence of the corporation is perpetual.

ARTICLE IV

The location and post office address of the registered office

and principal place of business of said corporation shall be 2195 Ironwood Court, Coeur d'Alene, Idaho 83814, and the registered agent shall be James McMillen.

#### ARTICLE V

The corporation shall have no capital stock.

#### ARTICLE VI

The corporation shall have no members.

#### ARTICLE VII

The business of the corporation shall be managed by a Board of Directors consisting of no fewer than three (3) nor more than five (5). Qualifications, terms of office, manner of election, powers and duties of such Directors shall be such as may be prescribed by law, these Articles and such By-Laws as may from time to time be in force.

#### ARTICLE VIII

Women's Center, Inc., an Idaho Non-Profit Corporation has the authority to, and designates the following named persons shall serve as a Board of Directors until their successors are duly elected and qualified, to-wit:

The corporation shall exercise powers in relation to its general powers in furtherance of exempt purposes for tax consequences.

By-Laws not inconsistent with the Articles of Incorporation may be adopted, altered, amended or repealed by a majority vote of the Board of Directors at any regular meeting, provided, however, a quorum, which shall be two (2) Directors, shall

be present.
