ARTICLES OF INCORPORATION

OF

VESTERN ADVERTISING, INC.

KNOW ALL MEN BY THESE PRESENTS:

That the undersigned, DOUGLAS D. KRAMER, MILO W. POPE and FREDERICK F. PLANKEY, each residents of the State of Idaho and residing in the County of Twin Falls, State of Idaho, each and all citizens of the United States of America, of the age of majority, do hereby associate themselves together for the purpose of forming a corporation under the laws of the State of Idaho, and to that end, do hereby adopt and execute the following articles of incorporation, and do hereby certify and declare:

I.

That the name of said corporation is and shall be WESTERN ADVERTISING, INC.

II.

That said corporation is formed for the following pur-

- a. To manufacture, buy, sell, lease, and otherwise to dispose of at either wholesale or retail, and generally trade in and deal with electric or other advertising displays, signs, advertisements and advertising devices, and generally to operate, engage in, and conduct an advertising sign business.
- b. To receive, acquire, hold, purchase, dispose of, convey, mortgage and/or lease, real and personal property; to dispose of, sell, lease, assign, transfer, mortgage and/or convey any rights, privileges, franchises, real or personal property of the corporation, other than its franchise of being a corporation, and to acquire, purchase, guaranty, hold, mortgage, own, vote,

sell, pledge and/or otherwise dispose of and deal in shares, bonds, securities and debentures and other evidences of indebtedness of other corporations, domestic or foreign.

- c. To conduct business in this state, other states, District of Columbia, and to have one or more offices and places of business out of this state, and to acquire, receive, hold, purchase, lease, mortgage, dispose of and/or convey real and personal property situate out of this state.
- d. To enter into, make, perform and carry out contracts of every kind and for any lawful purpose, without limit as to amount, with any person, firm association, corporation, municipality, state or government, or any subdivision, district or department thereof.
- e. To do any and all such other acts, things, business of businesses in any manner connected with or necessary, incidental, convenient or auxiliary to any of the objects hereinabove enumerated, or calculated, directly or indirectly, to promote the interest of the corporation; and in carrying on its purposes, or for the purpose of attaining or furthering any of its business.
- f. The several clauses contained in this statement of purposes shall be construed as both purposes and powers, and the statements contained in each clause shall be in nowise limited or restricted, by reference to, or inference from, the terms of any other clause, but shall be regarded as independent purposes and powers; and no recitation, expression, or declaration of specific or special powers or purposes herein enumerated shall be deemed to be exclusive; but it is hereby expressly declared that all other lawful powers not inconsistent herewith are hereby included.

That the location and post office address of the registered office of the componation shall be 210 6th Avenue East,

IV.

That, subject to dissolution in the manner provided by law, the duration of this corporation shall be perpetual.

V .

That the amount of the authorized stock of said corporation shall be Fifty Thousand (\$50,000.00) Dollars, divided into

Five Hundred (500) shares of common stock at the par value
of One Hundred (\$100.00) Dollars each.
