

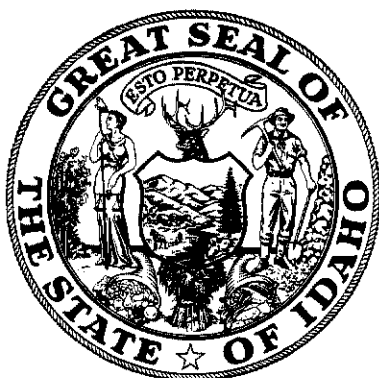
CERTIFICATE OF INCORPORATION

ARTICLES OF INCORPORATION

The undersigned acting as incorporator of a corporation under the Idaho Business Corporation Act adopts the following articles of incorporation for such corporation.

ARTICLE I.

The name of the corporation shall be Silver Dynamics, Incorporated.

ARTICLE II.

The principal office of the corporation in the State of Idaho is at Wallace, County of Shoshone, State of Idaho. The registered agent at this address is Everett McGregor. Corporate Mail is to be addressed to said agent at 306 Third St., Wallace, Idaho 83873.

ARTICLE III.

The corporation shall be perpetual existence unless sooner by lawful act of corporation of the corporation or by reason of law.

ARTICLE IV.

The purpose for which this corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act with the following specific purposes.




1. To engage in a general profit making business from the manufacturing and marketing of silver products, jewelry and associated products.
2. To hire and retain such salaried or hourly employees, including the incorporators as may be convenient or necessary for the carrying out of these purposes.
3. To issue stock and stock certificates in the proposed corporation and to market or trade the same; and enter into any financial arrangements convenient to these purposes, including the public sale of stock, floating of debentures, borrowing of money, purchase of another corporation or corporation stock, purchase of private or public debentures; and to form subsidiary corporations or enter into merger agreements as maybe considered convenient by the corporation.

ARTICLE V.

The aggregate number of shares which the corporation shall have authority to issue is one hundred thousand (100,000), the said shares shall have no par value.

ARTICLE VI.


