Pursuant to Idaho Code Sections 30-1-84, 30-1-92 and 30-1-93 of the Idaho Business Corporation Act, Northwest Properties, Inc., an Idaho corporation, hereby adopts the following Articles of Dissolution for the full and complete dissolution and liquidation of said corporation:

FIRST: The name of the corporation is Northwest Properties, Inc., an Idaho corporation, and its post office box address is 6062 Morris Hill Lane, Boise, Idaho, 83704.

SECOND: The names and addresses of the last officers and directors of the corporation and their respective offices are:

FOURTH: There are no debts, obligations or liabilities of Northwest Properties, Inc., and all past debts, obligations and liabilities have been paid and discharged in full; but adequate provision has been made for any unknown creditors of the corporation

as Extended Systems Incorporated, an Idaho corporation, has assumed and agreed to pay the same as part of a reorganization of the corporations.

FIFTH: All remaining property and assets of Northwest Properties, Inc., have been distributed to the shareholders in exchange for surrender and cancellation of their respective stock pursuant to a written agreement signed by the director and all shareholders by unanimous agreement.

SIXTH: There are no suits pending against the corporation in any court in the state of Idaho or elsewhere, but that adequate provision has been made for the satisfaction of any judgment, order or decree which might hereafter be entered against the corporation in that Extended Systems Incorporated, an Idaho corporation, has assumed and agreed to pay the same as part of a corporate reorganization.

SEVENTH: This dissolution has received the unanimous written consent of all shareholders by their respective execution of a Reorganization and Liquidation Agreement dated January 5, 1989.
