CERTIFICATE OF AMENDMENT TO ARTICLES OF INCORPORATION OF

THE PEOPLES CHURCH OF COEUR D'ALENE, INC.

The Peoples Church of Coeur d'Alene, Inc., a corporation of the State of Idaho, formed under and pursuant to Title 30, Chapter 11, Idaho Code, hereby certifies pursuant to the provisions of Idaho Code, Section 30-1103, that at a meeting of the members of said corporation called for the purpose of amending the Articles of Incorporation and held, on Wednesday, the lst day of November, 1972, it was resolved by the unanimous vote of all members attending such meeting, that the Articles of Incorporation be amended to add thereto the following: ARTICLE VIII.

In the event of dissolution, the assets of this corporation remaining after the payment of all debts and liabilities shall be donated to an organization or organizations formed and operating strictly for charitable, educational or other non-profit corporation having similar objects and purposes as this corporation within the meaning of Section 501 (C) (3) of the Internal Revenue Code.

The foregoing Amendment to the Articles of Incorporation of the Peoples Church of Coeur d'Alene, Inc., an Idaho corporation was done in conformity with the provisions of Idaho Code Section 30-1103 at a meeting of the membership held at the Seventh Day Adventist Church, 111 Locust Avenue, Coeur d'Alene, Kootenai County, State of Idaho, at 7:30 o'clock,

P. M., on November 1, 1972, at which time and place the
members of the association present at the meeting unanimously voted
