




**CERTIFICATE OF INCORPORATION

The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

I.

The name of the corporation is S & R LAND AND LIVESTOCK, INC.

II.

The period of duration is perpetual.

III.

The purpose or purposes for which the corporation is organized are: The transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

IV.

The aggregate number of shares which the corporation shall have authority to issue is Five Hundred Thousand (500,000) of One Dollar \$1.00 par value.

V.

Provisions denying preemptive rights are: None.
