

Articles of Incorporation

That all men by these provisions in the territory and have this day voluntarily associated themselves together for the purpose of forming a corporation under the laws of the Territory of Idaho, and we hereby certify,

First That the name of said corporation is the Hayden, Wadley and Wadley Company

Second That the purpose of said corporation is to engage in business on the business of mining for gold, silver and other precious metals, including the mining and smelting

Third That the purpose of said corporation is to engage in business for prospecting and mining and smelting and other business including the mining and smelting of gold, silver and other precious metals, including the mining and smelting of these metals, and ^{to} ~~conducting~~ ^{mining} and smelting operations in all their branches and to secure water and water rights for mining and smelting purposes in the Territory of Idaho

Fourth That the place of business of said corporation is to be held in the town of Hayden, County of Blaine, Idaho

Fifth That the term for which it is to exist is twenty years from and after the date of the incorporation

Sixth That the number of its members shall be five and that the names and residences of those who are appointed for the first year are

That the amount of capital stock of this Corporation shall be Three hundred thousand ~~shares~~ divided into ~~three~~ hundred thousand shares of the par value of one dollar each
