

# Articles of Incorporation of the Weiser City Water Ditch and Irrigating Company

Know all men by these presents that we Robert Morehead Solomon M Jeffays and E E Utley all of Washington County Idaho Territory do hereby and by these articles of Incorporation incorporate ourselves our and each of our successors associates and assigns a body Corporate for the purpose and uses in these articles mentioned and set forth under and by virtue of an act of the Legislative assembly of the Territory of Idaho approved January 12th 1875 entitled and designated in the Revised Statutes of Idaho an act "Concerning Corporations" and all amendments thereto

## Article I

The name assumed by this corporation and by which it shall be known is the Weiser City Water Ditch and Irrigating Company

## Article II

The enterprise business and permit in which this Corporation proposes to engage is the Construction and operation of a water Ditch through which to flow and convey water from Weiser River and Manns Creek for

Mechanical and Irrigating purposes the head of said Ditch or the point where shall intersect with and appropriate the water from said Weiser River to be at or near the East line of James Galloway's land claim and the west line of the land claim of James Jeffays at the point where the said line touches said Weiser River Running thence in a westerly direction to Mann's Creek and into and across the same and along the side or artificial channels thereof mingling and flowing the waters conveyed by said Ditch from the said Weiser River into and with the waters of the said Mann's Creek - also claiming and appropriating one thousand inches of the water of said Mann's Creek at the said crossing of the said Creek and from the side and artificial channel thereof thence running and continuing in the said westerly direction upon the most practicable and best grade to a point where said Ditch and line approaches nearest the East bank of Mann's Creek thence to Washington Mills all being situate in Washington County Idaho Territory Together with such branches and side ditches as may be necessary to enjoy the use of said water conveyed by said main ditch for purposes

herin before mentioned and set forth -  
the capacity of said ditch from its head  
to the point where crosses and mingles  
with the waters of Manns Creek shall  
be and is One thousand inches and the  
amount of water claimed from the said  
Weiser River and to be appropriated by  
said ditch from the channel of said Weiser  
River is One thousand inches the capacity  
of said ditch from the said Manns Creek  
to its final objective point shall be Two  
thousand inches of water of miners measure  
which said rule of measurement shall  
apply to all points of said ditch and  
water herin mentioned.

### Article III

The amount of capital stock of this  
Corporation is hereby fixed at Three  
Thousand dollars

### Article IV

The number of shares into which the  
Capital Stock of this Corporation is divided  
in Sixty Shares and of the value  
fifty dollars Each

### Article V

The place where this Corporation  
proposes to have its office or place busin-  
ess is Weiser City Washington County Idaho  
Territory

### Article VI

The duration of this Corporation shall be fifty years

Article VII

The number of trustees who shall manage the affairs of this Corporation for the first three months of its duration shall be three and Robert Morehead Solomon M Jeffays and E E Utley are hereby constituted such trustees

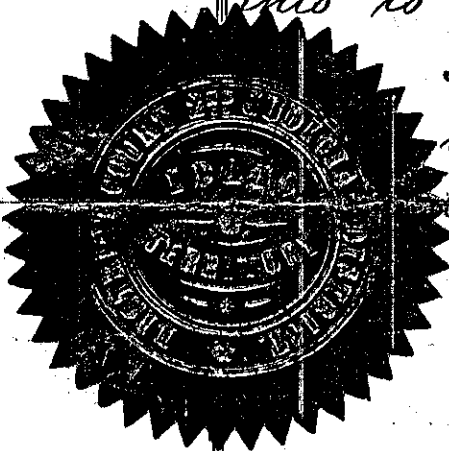
