

ARTICLES OF INCORPORATION.

The undersigned hereby associate themselves together as private corporation.

FIRST.

The name of this corporation shall be "The Texas Ensor Remedy Company.

SECOND.

The purpose for which this corporation is formed is to introduce what is known as "The Ensor Remedy" for the treatment of persons addicted to the excessive use of liquor, morphine, opium and tobacco.

THIRD.

The principal place of business of this corporation is Pocatello, Idaho, with a branch office at Fort Worth, Texas.

FOURTH.

The duration of this corporation shall be fifty (50) years.

FIFTH.
