ARTICLES OF INCORPORATION
OF
IDAHO DERMATOLOGY SOCIETY, INC.

ARTICLE I.

SECTION 1. This corporation shall be called Idaho Dermatology Society, INC.

SECTION 2. This corporation shall be a non-profit corporation organized under the laws of the State of Idaho for non-profit corporations as set forth in Title 30, Chapter 3.

SECTION 3. This corporation shall have a perpetual existance.

SECTION 4. The object and purpose of this corporation shall be to further by study, research, publication and teaching the knowledge of acute and chronic diseases of the skin and the application of such knowledge to the prevention and treatment of those diseases.

SECTION 5. This corporation is a non-profit corporation.

ARTICLE II.

SECTION 1. The membership of this corporation shall be evidenced by a membership certificate which may be a card. All the rights and interest of all members of this corporation are equal and no member can have or acquire a greater interest therein than any other member. The membership shall be open to all individuals who are Board Certified or Board Eligible by the American Board of Dermatology.

ARTICLE III.

SECTION 1. The government of this association shall be vested in the executive committee consisting of three (3) members. These said members of the executive committee shall be elected and selected in accordance with the by-laws of this association.

SECTION 2. The principal place of business and main office of the association shall be 116 West State Street, Boise, Idaho.

SECTION 3. The initial registered office of the corporation is 116 West State Street, Boise, Idaho, and the name of its initial registered agent at such address is Frank W. Crowe, M.D.

SECTION 4. The following constitutes the names and incorporators and addresses of the initial/executive committee:

ARTICLE IV.

All amendments to these articles shall be made under the requirements of Idaho Code 30-325, 30-326, and 30-327.

ARTICLES V.

This association shall be governed and operated through and by the executive committee, and/or the members of this association in accordance with a set of bylaws, hereinafter to be adopted, which said bylaws shall be in harmony with these Articles of Incorporation and/or the laws of the State of Idaho. The bylaws must be approved before they become effective by a 2/3 vote of the membership present at the corporation organization meeting.




